CHLORANTRANILIPROLE

There were no adverse effects in subchronic feeding studies in rats, mice or dogs. There was a decreased body weight gain at high doses in a 28-day feeding study in mice and in a 28 day dermal study in rats.

Animal testing indicates Chlorantraniliprole Technical (DPX-E2Y45) did not have carcinogenic, neurological, developmental or reproductive effects.

Tests have shown that Chlorantraniliprole Technical (DPX-E2Y45) did not cause genetic damage in bacterial or mammalian cell cultures, or in animals.
